BANK NIFTY – 53,714.65 (Daily Chart)



• In Tuesday's trading session, the banking index opened on a negative note and remained sideways during the first half of the session. However, in the second half, the index gained bullish momentum, helping it close on a positive note.

• On a daily scale, the index has formed a bullish candle, which helped it defend the crucial horizontal support level of 52,750. Despite the recovery, the index continues to maintain its bearish structure, as it is still forming a pattern of lower highs. For a meaningful trend reversal, the index needs to breach and sustain above 55,585.

• For Wednesday's trading session, 53,580 will act as the initial support level, while on the higher end, 53,940 will act as the initial resistance level.

ADANI PORT: The company's cargo volumes rose 15% year-on-year, reflecting steady growth in port operations, while logistics rail volumes declined 19% from a year earlier. The mixed operational performance highlights strength in cargo handling despite weakness in the rail logistics segment.

VEDL : Vedanta said officials from the Enforcement Directorate (ED) visited certain offices of the company and its subsidiary, Hindustan Zinc. The company stated that it is fully cooperating with the authorities and is providing all information and assistance sought during the process.

CANBK : State-owned Canara Bank has approved plans to raise up to ₹8,500 crore in FY27 through debt instruments to strengthen its capital base and support business growth. The lender will raise up to ₹4,500 crore via Basel III-compliant AT1 bonds and up to ₹4,000 crore through Tier II bonds, subject to market conditions and regulatory approvals.

- The US has reduced tariffs on farm equipment to 15% and introduced a new 10% tariff for products using at least 85% US-origin metals. These changes, lasting until December 31, 2027, aim to lower costs for American farmers and manufacturers. However, core metal tariffs remain high, with limited overall benefit expected for India.
- UK Foreign Secretary Yvette Cooper is visiting India soon. Discussions will focus on the proposed Free Trade Agreement. Trade and investment ties will be strengthened. Security and defence cooperation is also on the agenda. UK Business and Trade Secretary Peter Kyle is also in India. He is meeting with Indian officials to advance the trade relationship.
- Venezuela's interim President Delcy Rodriguez will travel to India on Wednesday for a five-day visit, the foreign ministry said, as New Delhi scales up crude imports from Caracas. Rodriguez will be accompanied by several ministers and will hold meetings with Prime Minister Narendra Modi, said foreign ministry spokesman Randhir Jaiswal.
