NIFTY – 24,774.30 (Daily Chart)



• In Monday's trading session, the Nifty opened with a gap up but failed to build on its early gains, trading sideways for most of the session. However, strong buying interest emerged towards the end of the day, resulting in the formation of a strong bullish candle and helping the index close on a positive note.

• On a daily scale, the index has formed a strong bullish candle, enabling it to decisively close above the key horizontal resistance level of 24,610. The RSI continues to trend higher, indicating improving momentum and underlying strength. Additionally, the index is now trading above all major moving averages, which reinforces the positive technical outlook and strengthens the bullish bias.

• For Tuesday's trading session, 24,515 will act as the initial support level, while on the higher end, 24,775 will act as the initial resistance level.

BANK NIFTY – 58,247.95 (Daily Chart)



- In Monday's trading session, the banking index opened with a huge gap up and traded sideways for most of the session. However, strong buying interest emerged towards the end of the day, helping the index rally sharply and close at its day's high.
- On a daily scale, the index has formed a strong bullish candle, enabling it to decisively breach and close above the 20 DEMA, which is a positive sign for the bulls. The index is now gradually moving towards the key horizontal resistance level of 58,710. Meanwhile, the RSI is trending higher, indicating improving momentum and strengthening bullish sentiment.
- For Tuesday's trading session, 57,575 will act as the initial support level, while on the higher end, 58,250 will act as the initial resistance level.





DLF : Realty major reported a consolidated net profit of ₹793.9 crore for the first quarter, up 4.1% from ₹762.7 crore in the corresponding period last year. Revenue declined 52.9% year-on-year to ₹1,280.3 crore from ₹2,716.7 crore in Q1 FY26.

IREDA : State-owned Navratna firm Indian Renewable Energy Development Agency reported a 36.8% year-on-year increase in net profit for the June quarter, driven by growth in its lending business. The company's net profit rose to ₹337.5 crore in the first quarter of FY27 from ₹246.7 crore a year earlier.

UPL : Agrochemical and crop protection company UPL Ltd on Monday reported consolidated net profit of Rs 10 crore during the quarter ending June 30, 2026. The company had a net loss of Rs 88 crore during the corresponding quarter of the previous fiscal year, UPL said in a regulatory statement. Revenue from operations grew by 10.47 per cent to Rs 10,181 crore during the quarter under review, compared to Rs 9,216 crore during the same period last year.

- The government is set to release ₹4,000 crore this fiscal year under the Auto-PLI scheme, designed to stimulate production and investment among qualified companies. Notably, Bajaj Auto has already benefited, receiving ₹750 crore for meeting its incremental sales targets for fiscal year 2026. Substantial funds have been allocated to support this initiative, underscoring its significance.
- Commerce and Industry Minister Piyush Goyal urged India and Uzbekistan to double bilateral trade from the current \$1.5 billion within three years, highlighting opportunities in mining, textiles, pharmaceuticals, healthcare and digital infrastructure. He also called for greater co-investment, co-manufacturing and co-innovation, saying the recently concluded Bilateral Investment Treaty would boost investor confidence.
- A bill will soon simplify offshore investment fund rules. This aims to attract more foreign capital into India. Tax exemptions will be offered for global income of funds. Foreign companies storing electronic components will also get exemptions. These measures will boost India's position as an investment hub.
