NIFTY – 23,431.50 (Daily Chart)



- In Wednesday's trading session, the Nifty opened with a gap down and remained largely sideways for most of the trading session, resulting in a negative close.
- On a daily scale, the index has formed a strong bearish candle and continues to maintain its bearish structure, forming a pattern of lower lows and lower highs. The index also continues to trade below the 20 DEMA, indicating that bearish momentum remains intact. The RSI has slipped below the oversold zone, which is a cautious sign for the bears and could indicate the possibility of a short-term recovery.
- For Thursday's trading session, 23,430 will act as the initial support level, while on the higher end, 23,655 will act as the initial resistance level.

BANK NIFTY – 57,088.30 (Daily Chart)



- In Wednesday's trading session, the banking index opened with a gap down. However, during the session, the index managed to cover the gap before resuming its southward journey and eventually closed at the day's low.
- On a daily scale, the index has formed a strong bearish candle with an upper wick, indicating selling pressure at higher levels. The index continues to trade below the 20 DEMA, indicating that bearish momentum remains intact. The RSI is gradually moving southward, indicating continued weakness in the index.
- For Thursday's trading session, 56,290 will act as the initial support level, while on the higher end, 56,765 will act as the initial resistance level.





HINDZINC : The firm has signed a six-year transportation contract with MFL India to deploy 30 electric trucks for moving zinc and lead concentrate from its Rampura Agucha mine to smelting facilities in Rajasthan.

COALINDIA : State-owned firm said its major coal-producing subsidiary, Northern Coalfields Ltd (NCL), has accelerated coal production and dispatch as rainfall eases, with production rising 67% and supply increasing 75% as of September 8, compared with the average for September 1-3.

ICICIBANK : The bank said on Wednesday that ICICI Prudential Asset Management Company Limited has received approvals from the Reserve Bank of India (RBI) to acquire an aggregate holding of up to 9.95% of the paid-up share capital or voting rights in four banks.

WIPRO : The firm and CrowdStrike have launched a cybersecurity command centre to help companies detect and respond to growing cyber threats, including those enabled by artificial intelligence.

- India's minister will meet Russian and EAEU counterparts to advance trade deal talks. Negotiations for a trade pact with the Eurasian Economic Union are in advanced stages. India seeks to diversify export markets and reduce its significant trade deficit. Bilateral trade targets with Russia are set at approximately one hundred billion dollars. BRICS trade has doubled, with imports significantly outpacing exports.
- National Highways Authority of India now requires 80% plantation coverage for project completion. A minimum 90% sapling survival rate is also mandated for provisional certification. Financial withholdings will enforce outstanding plantation work completion and target achievement. Payments during the operations period will link to maintaining plant survival rates. Timely replacement of dead or damaged plants is now a mandatory requirement.
- India's merchandise exports saw over fifteen percent growth from April to August. The nation has set ambitious export targets for the upcoming fiscal year. BRICS nations possess significant potential for expanding trade in goods and services. Discussions also focused on improving trade facilitation and digitalizing trade documents. India and Thailand reviewed their trade agreement to boost bilateral engagement.
