

### NIFTY – 25,355.25 (Daily Chart)



• In Thursday's trading session, the Nifty opened in the red and remained under pressure throughout the day, ending with a negative close.

• On the daily chart, the index formed a bearish candle near the horizontal resistance level, indicating selling pressure at higher levels. However, it managed to hold above the 20-day exponential moving average (20 DEMA) — a key support for the bulls. The index needs to decisively breach the resistance at 25,675 to resume its upward trajectory.

• For Friday's session, 25,345 will act as the initial support level, while 25,420 will serve as the initial resistance.



### BANK NIFTY – 56,956.00 (Daily Chart)



• In Thursday's trading session, the banking index opened on a positive note but soon slipped into the red and gradually moved lower, ending with a negative close.

• On the daily chart, the index formed a bearish candle near the horizontal resistance level, signaling selling pressure at higher levels. However, it continues to hold above the 20-day exponential moving average (20 DEMA) — a key short-term support. To regain bullish momentum, the index must decisively break above the resistance level of 57,640.

• For Friday's session, 56,940 will act as the initial support level, while 57,155 will serve as the initial resistance.

#### STOCK'S IN NEWS

**TATAELXSI**: Tata Elxsi, a Tata Group company, saw its net profit fall by 22%. This decline is due to economic uncertainties and issues affecting R&D spending. The company's revenue also decreased by 3.7%. Weakness in the automotive sector contributed to this drop. Despite challenges, Tata Elxsi aims to protect its business and expand customer relationships. The company's shares closed slightly lower.

TCS : India's largest software services firm reported a 6% year-on-year (YoY) rise in Q1 FY26 net profit to ₹12,760 crore. Revenue dipped 1.6% quarter-on-quarter (QoQ) to ₹63,437 crore. EBIT stood at ₹15,514 crore with a 24.5% margin, and the board declared a ₹11/share dividend.

**IREDA** : State-run renewable energy company has reported Q1 FY26 net profit of ₹247 crore, down 35.7% YoY, while revenue rose 28.9% to ₹1,947 crore. However, asset quality deteriorated, with gross NPA rising to 4.13% from 2.45% in the March quarter, and net NPA increasing to 2.05% from 1.35%.

- India and the US are actively negotiating a trade deal. Indian negotiators will soon visit the US to advance talks.
  Both countries aim to finalize the first phase by Fall. An interim trade deal is also being considered. India has already implemented multiple FTAs and seeks to integrate further with major economies.
- India has adjusted its plan for retaliatory tariffs on the US due to increased duties on steel and aluminium. The WTO received India's request to modify tariffs on American goods. This action follows the US raising tariffs to 50 percent. India's move aims to collect equivalent duties from US products.
