NIFTY – 24,435.95 (Daily Chart)



• In Wednesday's trading session, the Nifty opened on a negative note and remained under pressure for most of the session. However, towards the end, the index recovered from its intraday lows, helping it trim most of its losses and close on a flattish note with a negative bias.

• On a daily scale, the index has formed a small bearish candle with a long lower wick, indicating recovery from lower levels. Although the index breached the support of the 20 DEMA and 100 DEMA during the session, the subsequent recovery helped it close back above both levels, which is a positive sign for the bulls. To resume its upward journey and regain bullish momentum, the index needs to decisively breach and sustain above the recent high of 24,774.

• For Thursday's trading session, 24,265 will act as the initial support level, while on the higher end, 24,495 will act as the initial resistance level.



BANK NIFTY – 57,885.85 (Daily Chart)



- In Wednesday's trading session, the banking index remained in positive territory throughout the session, helping it outperform the broader market.
- On a daily scale, the index has formed a strong bullish candle, enabling it to close above the 20 DEMA, which is a positive sign for the bulls. However, to resume its upward journey and strengthen bullish momentum, the index needs to decisively breach and sustain above the key horizontal resistance level of 58,710.
- For Thursday's trading session, 57,470 will act as the initial support level, while on the higher end, 57,900 will act as the initial resistance level.





ASTRAL : Ahmedabad-based building materials and equipment company reported a 51.8% year-on-year increase in consolidated net profit to ₹120 crore for the first quarter of FY27, compared with ₹79 crore in the year-ago quarter.

APOLLOHOSP : Healthcare provider reported a 38.4% year-on-year increase in consolidated net profit to ₹610 crore for the first quarter of FY27, compared with ₹441 crore in the corresponding quarter last year.

ABBOTINDIA : Drug firm reported a 17.12% year-on-year rise in consolidated net profit to ₹429 crore for the first quarter of FY27, compared with ₹366 crore in the year-ago quarter.

TMCV : The firm reported an 83.3% year-on-year rise in consolidated profit attributable to owners of the company to ₹2,560 crore for the quarter ended June 30, 2026, compared with ₹1,397 crore in the year-ago quarter. Consolidated revenue from operations rose 19.30% to ₹20,667 crore from ₹17,324 crore a year earlier.

- India saw its retail inflation rise to 4.45 percent in July compared to June's 4.38 percent, largely due to rising food prices, which are keeping consumer costs elevated. The Reserve Bank of India has adjusted its inflation prediction for FY27 down to five percent. Excluding precious metals, core inflation seems to be under control. Experts anticipate that headline inflation will reach its peak in the third quarter before easing off.
- Bank deposits saw their fastest growth in nearly ten years by July. Overseas Indians deposited about \$37 billion in foreign currency accounts. Bank credit growth also accelerated to its fastest pace since June 2024. This surge was driven by corporate demand and MSME lending programs. India garnered nearly \$41 billion in total inflows by July 31.
- Finance Minister Nirmala Sitharaman emphasized the challenges faced by BRICS nations in mobilizing private capital. She urged multilateral institutions to draw investors into infrastructure projects, as India needs ample private investments alongside its public capital. A substantial pipeline of infrastructure projects is being cultivated through public-private partnerships, allowing the group to target resilient and sustainable growth through meaningful cooperation outcomes.
