

#### NIFTY – 24,619.35 (Daily Chart)



- •In Wednesday's trading session, the Nifty opened with a gap-up and gradually moved north, ending the day on a positive note.
- On the daily scale, the index formed a small bullish candle with equal wicks on both ends, indicating indecisiveness among market participants. Despite the positive close, the bearish structure remains intact as the index continues to form lower lows and lower highs. It is still trading below the 20 DEMA, signaling continued bearish momentum. A sustained move above the 20 DEMA will be required to indicate a potential trend reversal.
- For Thursday's trading session, 24,595 will act as the initial support level, while 24,685 will serve as the initial resistance level.



#### BANK NIFTY – 55,181.45 (Daily Chart)



- In Wednesday's trading session, the banking index opened on a positive note but failed to sustain its bullish momentum, moving sideways for most of the session and ending with a marginally positive close.
- On the daily scale, the index continues to hold its bearish structure, forming lower lows and lower highs. It remains below the 20 DEMA, indicating a continuation of bearish momentum.
- For Thursday's trading session, 55,285 will act as the initial resistance level, while 55,140 will serve as the initial support level.

#### STOCK'S IN NEWS

**MUTHOOTFIN**: The gold loan lender posted an 89.6% YoY jump in Q1FY26 net profit to ₹2,046 crore, its highest-ever quarterly profit. Net interest income rose 50.6% to ₹3,473 crore, with NIMs improving to 12.15% from 11.51% a year ago.

**UNITDSPR**: The alcohol and beverage company's Q1 net profit fell 13.7% YoY to ₹258 crore, while revenue rose 8.4% to ₹2,549 crore. EBITDA dropped 9.4% to ₹415 crore, with margins narrowing to 16.3% on higher costs and increased brand reinvestment.

**BPCL**: BPCL posted a 22.8% QoQ jump in Q1 net profit to ₹6,124 crore, while revenue rose 1.2% to ₹1.13 lakh crore. EBITDA climbed 24.4% QoQ to ₹9,663.3 crore.

**ZYDUSLIFE:** The company said the US FDA has closed its inspection of the SEZ II, Ahmedabad plant, conducted August 11–13 for three products and cGMP compliance, with no observations.

**JUBLFOOD**: The company's Q1 net profit rose 29.5% YoY to ₹66.7 crore, while revenue grew 18.2% to ₹1,702 crore. EBITDA was up 16.3% to ₹323.5 crore, with margins at 19%.

#### **ECONOMIC NEWS**

- Chief Economic Advisor Nageswaran anticipates US tariff challenges to ease within two quarters, urging private sector engagement to address long-term issues like AI and critical mineral reliance. He attributed FY25's growth slowdown to tight credit and highlighted agriculture's potential to boost GDP. Nageswaran also emphasized the need for diversified import sources and cautious AI adoption to mitigate labor displacement.
- Amid growing interest in rupee-rouble transactions, the Reserve Bank of India has simplified rupee trade settlements with Russia. This move allows authorized banks to open special rupee accounts, streamlining payments and reducing reliance on the dollar. Challenges remain due to trade imbalances and currency volatility, but measures are being explored to enhance efficiency and mitigate risks.
