# NIFTY – 24,196.75 (Daily Chart)



- In Thursday's trading session, the Nifty opened on a positive note but failed to sustain at higher levels and gradually moved southward, resulting in a negative close.
- On a daily scale, the index has formed a bearish candle. It slipped below the 50 DEMA during the session but managed to close above it, which is a positive sign for the bulls. The RSI is gradually moving northward, indicating underlying strength in the index.
- For Friday's trading session, **24,100** will act as the initial support level, while on the higher end, **24,265** will act as the initial resistance level.



# BANK NIFTY – 56,086.40 (Daily Chart)



• In Thursday's trading session, the banking index opened with a gap up but failed to sustain at higher levels and gradually moved southward, resulting in a negative close.

• On a daily scale, the index has formed a bearish candle and failed to sustain above the 50 DEMA level, which is a cautious sign for the bulls. The RSI is moving sideways, indicating a neutral trend. With multiple gaps still pending to be filled, bulls are likely to remain cautious in the near term.

• For Friday's trading session, 55,890 will act as the initial support level, while on the higher end, 56,485 will act as the initial resistance level.

**ANGELONE** : The firm reported a sharp rise in earnings for the fourth quarter on Thursday, April 16, with net profit climbing 83.5% year-on-year to ₹320 crore. Revenue for the quarter grew 38.2% to ₹1,459 crore from ₹1,056 crore in the year-ago period, reflecting stronger client activity.

- Government employees are pushing for major changes in pay and pensions with the Eighth Central Pay Commission. They want a higher basic salary and better benefits. Proposals include a new fitment factor and merging dearness allowance with basic pay. The plan also covers cadre restructuring and family-friendly policies.
- India's exports of engineering goods, auto parts, and machinery to Europe face potential carbon tax hikes as the EU expands its Carbon Border Adjustment Mechanism. Starting 2028, the CBAM will cover a wider range of manufactured industrial goods, including stricter rules for recycled materials. This move could significantly impact Indian manufacturers exporting to the bloc.
