


# ITI Morning Boost

# NIFTY – 25,725.40 (Daily Chart)



- In Tuesday's trading session, the Nifty opened with a gap down but managed to recover from the day's low and cover the gap. After filling the gap, the index moved in a sideways direction, resulting in a flattish close with a positive bias.
- On a daily scale, the index has formed a small bullish candle with wicks on both ends, indicating indecision. The index managed to hold the support of the 20 DEMA level, which is a positive sign for the bulls. To gain stronger bullish momentum, the index needs to breach and sustain above the 26,340–26,380 resistance zone.
- **For Wednesday's trading session, 25,765 will act as the initial resistance level, while on the lower end, 25,660 will act as the initial support level.**

- In Tuesday's trading session, the banking index opened with a gap down but managed to recover from the day's low and cover the gap. After filling the gap, the index moved in a sideways direction, which helped it close on a positive note.
- On a daily scale, the index has formed a bullish candle with a lower wick, indicating recovery from lower levels. The index continues to trade above the 20 DEMA level, which is a positive sign for the bulls. To continue its bullish momentum, the index needs to breach and close above the 61,765 level.
- For Wednesday's trading session, **61,025** will act as the initial support level, while on the higher end, **61,245** will act as the initial resistance level.

**BHEL:** State-run company has secured a Letter of Acceptance (LoA) from Steel Authority of India Limited (SAIL) for a captive power plant at its IISCO Steel Plant in Burnpur, West Bengal. The LoA, received on February 17, 2026, relates to the Captive Power Plant (CPP) package (Pkg. No. CPP-1) for SAIL's 4.08 million tonnes per annum crude steel expansion project at Burnpur.

- A significant basmati rice deal has been struck. An Indian Rice Exporters Federation member will supply 5,000 tonnes to the United States. This agreement follows the finalisation of the India-US trade deal. America has agreed to reduce tariffs on Indian goods. This development is a positive step for Indian rice exports.
- India is actively engaging with global partners from a strong stance. Recent trade agreements highlight this enhanced international cooperation. These pacts are set to boost commerce and strengthen economic ties. The world is experiencing significant shifts in global order and economic dynamics. India's proactive approach positions it for future growth and influence.
- The National Green Tribunal has approved the Great Nicobar Island International Container Transhipment Terminal. The tribunal found that environmental safeguards are in place. This decision follows objections regarding coastal regulations. The project's strategic importance was considered alongside environmental protection measures. Authorities must ensure strict compliance with clearance conditions.
